Race Description: This is a 4-man relay race

- Course consists of 4 loops around the Blue Wahoos Stadium at the Maritime Park
- Each team member does one loop around the stadium (approx 3/4 mile per loop)
- At the transition area, each team member must effect a transfer of clothing to the next person in the relay—each team can choose the order in which they wear their four items
- Transition area is the grass area in front of the amphitheater
- Each team member must wear one of the following articles of clothing during the race: bandanna, hat, pair of sunglasses, and one pair of overalls
- Each team member will be issued a commemorative Smokin' In The Square bandanna
- Each team is responsible for bringing the remaining articles of clothing to wear during the race: one pair of overalls, one hat, and one pair of sunglasses
